LOCATION

Langthwaite Business Park is situated on the edge of the South Kirkby & South Elmsall urban areas. The estate is well established and is 9 miles from J32 of the M62 and 4.5 miles from J37 & 38 of the A1M.

Doncaster Airport is around 19 miles and Leeds/Bradford Airport is approximately 35 miles. Moorthorpe Railway Station is approximately one mile.

There are a variety of occupiers on the Estate, who include Production Park, Lite Structures, The Ice Co, Dempsey Dyer & Forest Freight Logistics.

DESCRIPTION

The warehouse is available in various sized areas from a minimum of 5,000 sq ft up to the full area of 48,000 sq ft. The offices are available separately as a whole or on a room by room basis, if required.

There are a number of loading doors and a yard to either side of the building which will allow the warehouse to be split into separate areas or give greater operational flexibility to the whole unit.

CCTV & ANPR estate security, run jointly by Wakefield Council and estate occupiers.

The building has an Energy Performance Assessment Rating of D 93.
